Congratulations to the board and staff of the California Air Resources Board (ARB) for the unanimous vote on August 24 to adopt the updated environmental analysis and re-affirm the AB 32 Scoping Plan. This is a significant step in California's march to address global climate change. California's cap-and-trade program will be a key mechanism to achieving the state's greenhouse gas (GHG) emissions reduction goals, and the Reserve is pleased to serve a central role in informing the program.
