Meeting Notes

- 1. Workgroup members went around and introduced themselves.
- 2. John Nickerson presented a summary of the first meeting with the quantification team held on June 17, 2013. Discussion included a desire to develop a 'wall to wall' accounting of forest carbon within urban boundaries using a canopy level assessment (e.g., remote sensing supported with ground-based inventory).

- 3. Discussion of proposed team members, assignments, tasks, and timeline for deliverables.
 - a. 3 teams with assigned issues to work on—decided to focus on two approaches concurrently across the teams: 1) revisions to existing protocol focused on tree planting activities, and 2) new approach based on a canopy-level assessment of carbon stocks.
 - b. Google Docs to share documents—can be uploaded and edited by anyone in the workgroup.
 - c. Informal notes to be written up and shared among teams; opportunity to come together periodically as a full workgroup to share progress; John and Emily to serve as bridge between teams as well.
 - d. Key discussions points included:
 - Moving away from tree sites as metric towards more sampling or plot-based approach
 - ii. Making the existing protocol more efficient and cost-effective—small team is going to take the lead on proposing areas within existing protocol to focus on for revision.
 - iii. Allowing more flexibility, more options for meeting requirements (e.g. let project developers choose between tree site-based approached or canopy-level approach).
 - iv. Expanding eligibility to include a larger area, more trees within scope of a project
 - v. Postponing the focus on aggregation of multiple ownerships until September, after groups have made some progress on issues within context of single entity.
