Stakeholder consultation on updating HNO₃,MAX in the Nitric Acid Production Project Protocol

Based on stakeholder input, the Reserve is exploring the possibility of allowing for updates to the historical maximum annual average total output of nitric acid (HNO_3,MAX) when a nitric acid plant (NAP) is upgraded or relocated. The Reserve would like to elicit feedback on proposed options for updating the requirements related to HNO_3,MAX , and will also be welcoming the submission of alternative proposals, including the possibility of making no change to the protocol text. The results of this stakeholder consultation may be used to inform a protocol clarification or included in a future protocol update. The Reserve will host a public webinar to discuss this issue with interested stakeholders. The webinar will be scheduled based on stakeholder availability, in February or March. Clarification issued for the Grassland Project Protocol


