A note from our President

Greetings,

As the new year begins, we are honored and humbled to reflect back upon our achievements and accomplishments made working in partnership with many of you during the past year.

The Reserve continued to grow and expand our programs and services in 2016. Our core offsets program grew to surpass the milestones of 85 million offsets issued and 25 million Climate Reserve Tonnes (CRTs) retired for environmental benefit. Under California's compliance offset program, the Reserve surpassed the milestone of 19 million Registry Offset Credits (ROCs) issued.

The Reserve also continued its advancement of climate solutions by adopting the Mexico Boiler Efficiency Project Protocol, which provides another opportunity for businesses in Mexico to participate in the North American carbon market. As climate change does not stop at geopolitical borders, we appreciate the importance and opportunity to collaborate with our neighbors.

In another cross-border collaboration, the Reserve supported and will continue to support the expansion of the North American carbon market by developing offset protocols for Ontario and Quebec in the coming year. The Reserve won a bid from the government of Ontario to develop 13 protocols to facilitate the creation of high quality offsets for use in GHG cap and trade programs that have been or may be implemented in Ontario and Quebec. 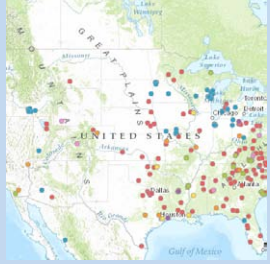

Reserve to support the development of offset protocols for Ontario and Quebec

On April 13, 2015 Ontario announced that it would introduce a cap and trade program to limit greenhouse gas emissions in Ontario. It is currently Ontario's intent to link its program with California and Quebec's joint program beginning in 2018. Ontario is working with Quebec to develop a supply of high quality offsets with integrity, transparency and financial value for its cap-and-trade program. To do this Ontario intends to establish regulatory standards for GHG emissions reduction projects, issue carbon offset credits generated from such projects, and track the issuance and transaction of credits in a highly secure and transparent system.

The Reserve has been retained by the Government of Ontario to develop 13 protocols to facilitate the creation of high quality offsets for use in the GHG cap and trade programs that have been or may be implemented in Ontario, Quebec, and potentially other provinces. The Reserve's partners for the work include Viresco Solutions, Brightspot Climate, Cap-Op Energy, Green Analytics and ÉcoRessources. Quebec is intimately involved in the project and is a funding partner.

Ontario has identified three priority project types for protocol development: landfill gas capture and destruction, ozone depleting substances capture and destruction, and mine methane capture and destruction. In addition, the Reserve will be adapting GHG offset protocols for N₂O reductions from fertilizer management in agriculture, livestock, organic waste digestion, organic waste management, forest, afforestation, urban forestry, grasslands,



conservation cropping, and refrigeration systems.

As the premier carbon offset registry for the North American carbon market, the Reserve looks forward to applying our knowledge and expertise in emissions accounting and offset program development to support the Ontario carbon market.
