With the generous support of the U.S. Department of Agriculture Natural Resources Conservation Service under the Conservation Innovation Grant (CIG) program, the Reserve is launching a significant Nitrogen Management Project Protocol (NMPP) revision and expansion. As a first step, the Reserve surveyed stakeholders on recommendations for the future expansion of the protocol. The Reserve is pleased to invite interested stakeholders, members of the Nitrogen Management Workgroup, and the general public to join this discussion of the results of the survey, the biggest takeaways, and next steps as the protocol update gets underway.

## Updated Verification Program Manual Available

The Reserve has released a new version of the Verification Program Manual, which provides verification bodies with guidance and requirements for a standardized approach to the independent and rigorous verification of GHG emission reductions and removals. Updates to the manual include training requirements, site visit frequency, and verification body accreditation, all of which are detailed in a Summary of Changes document.
