California Air Resources Board Adopts Reserve's Forest Project Protocol

On September 24, the California Air Resources Board unanimously adopted the Reserve's updated Forest Project Protocol, version 3.0. The updated protocol supports forestry projects throughout the country and allows for working forests and public lands to apply for registration. The recent adoption makes the Forest Project Protocol the country's only government-approved forestry protocol. The protocol ensures that forest projects result in permanent increased on-site carbon stocks, promotes natural forest management, and improves forest health through increased habitat and watershed protections. depleting substances (ODS), the Reserve has committed to producing a separate, complementary protocol for U.S.-based projects that destroy ODS imported from Article 5 (developing) countries. The "imports" protocol would expand the Reserve's scope to allow for the destruction of ODS imported from over 100 Article 5 countries worldwide. If adopted, this would be the first Reserve protocol allowing credit for avoided emissions in countries outside North America. Both the U.S. and imported ODS protocols are on track to be finalized and adopted in February 2010.

Draft N2O Protocol to be Released for Public Comment Next Week

The draft Nitrous Oxide (N2O) Project Protocol for nitric acid plants in the U.S. was reviewed by the workgroup and is now being revised by the Reserve. The revised draft will be released to the public for comment on October 13, 2009 and public comments will be due by 5:00 pm PDT November 10, 2009. A public workshop to discuss the draft protocol will be held at the end of the annual ANNA (nitric acid and ammonium nitrate producers) conference in Little Rock, Arkansas, on October 23, 2009 from 3:00 pm - 5:00 pm CDT at the Peabody Hotel. Reserve Signs Statement of Intent to Preserve the Forest Habitat of the Monarch Butterfly

The Climate Action Reserve signed a Statement of Intent to implement and support forest management and reforestation practices for the forests of the Sierra Madre Occidental States of Mexico and Michoacán. The SOI was signed by the Secretariat of Environment and Natural Resources of the United Mexican States (SEMARNAT), the California Environmental Protection Agency (Cal/EPA), the Climate Action Reserve and ECOLIFE Foundation. The collaborative, trans-border approach aims to reduce greenhouse gas (GHG) emissions, support the forests' vital ecological and economic functions and protect the Monarch Butterfly.
